- 1. No. of gases to be mixed: 3 Nos.
- 2. Mass flow controller range: 4 no's'; (0 5 SCCM-2 no) one each for corrosive and non-corrosive gas.

(0-10SLPM- Ino for balance gas) ;(0-100SCCM)-I no for corrosive gasat the final outlet after the buffer tank. Digital MFC with preloaded standard gases and display. Suitable user selectable modes should be available for selecting any specific gas chosen at a time of use. Simultaneously displays Mass Flow, Volumetric Flow, Pressure and Temperature.
